

## **PLAN FOR RESUMPTION OF IN-PERSON GATHERINGS AT FUUSE**

The aim of this document is to articulate a carefully thought-out plan for the resumption of in-person gatherings at FUUSE. The following guidelines hold for all phases:

1. Erring on the side of caution is, in all cases, both encouraged and expected.
2. The preferred venue for gathering continues to be online.
3. Resumption of in-person gatherings must be deemed “necessary” - meaning of clear benefit to the group or required by the nature of the task.
4. We request that groups be sensitive to those who are unable to meet in person - either due to vulnerability, physical limitations, or activities that place them at risk. Please give thought to not marginalizing people not able to attend in-person gatherings.
5. It is up to the leader of the group to ensure that all policies are enforced.

### **PHASE ONE**

Phase One is defined as small groups gathering on FUUSE property, outside, masked and physically distanced. We have determined that Phase One is appropriate - starting July 1, 2020 and extending through the summer - since new case numbers and hospitalizations are going down in our region. If this changes, Phase One will be revoked.

The following particular criteria apply to Phase One:

1. Gatherings are to take place outside. There will be absolutely no access to indoor spaces, including bathrooms.
2. Outside spaces must be reserved in advance.
3. Small groups - 10 people or fewer
4. No children, including infants
5. All participants are to wear masks at all times.
6. Physical distancing of at least 6' is to be maintained at all times.
7. The leader of the group is responsible for screening all participants on or before arrival. If any question is answered with a 'yes', that participant must be asked to leave/not participate. Screening questions include:
  - a. Have you had known exposure to Covid-19 in the past 14 days?
  - b. Have you traveled out of the country or on a cruise ship in the past 14-days?
  - c. Have you traveled outside of ME, NH, or VT on public transportation in the last 14-days?
  - d. Have you taken part in a mass gathering in the last 14 days?
  - e. Do you feel - either today or within the last 14 days - as though you have a fever or chills? A cough? Shortness of breath or difficulty breathing? Severe fatigue? Muscle or body aches? A new loss of taste or smell? Sore throat, congestion or runny nose? Abdominal pain, nausea, vomiting or diarrhea?
8. Every member of the group is responsible for bringing anything they need - including but not limited to a chair, a blanket to sit on, hand sanitizer, sunscreen, etc. Groups must fully clean up after themselves, leaving nothing (including garbage) behind.
9. Food and beverages are not to be shared during Phase One.
10. Leaders of in-person activities must keep records of dates and participants in case contact tracing is needed.
11. If a participant tests positive for Covid-19 within 14 days of being on FUUSE property, they should immediately contact the group's leader and the FUUSE Office Administrator, and the full list of participants must be provided to the FUUSE Office Administrator.
