When calculating which phase we are in, always go with the most restrictive phase based on Rockingham and Strafford County metrics: <https://www.covid19.nh.gov/dashboard/map>

- Must be at each phase for a minimum of two weeks before moving to next phase
- The parsonage and church building can only be accessed by staff with signing in and out
- No food until Phase 2, then individually packaged items only
- If you are not feeling well, please stay home
- Please use hand sanitizer when entering the building, before eating, after touching face and often
- Child is anyone <12 years

\*Outdoor conditions

- Scheduled through office
- 3-foot distancing
- Masks when within 6 feet of others

\*\* Indoor conditions

- Scheduled through office one activity in any given time frame
- Open windows
- 6-foot distancing
- Masks required
- Hand washing/sanitizing following contact with any surface
